## **USDA Recovery Resources for Tropical**

## **Storms and Hurricanes**

## August 6, 2024

The U.S. Department of Agriculture (USDA) Farm Service Agency (FSA) reminds producers impacted by a tropical storm or hurricane that FSA has programs and resources available to provide assistance in recovery efforts. USDA staff in Florida stand ready and are eager to assist our state's producers in the aftermath of any storm.

It is critical that producers keep accurate records to document damage or loss and report losses and damage to their <u>local USDA Service</u>

<u>Center</u> as soon as possible.

Additionally, due to long standing federal law, producers should not perform any clean-up efforts until an environmental evaluation has been completed by your local county office unless there is an immediate threat to human life. Failure to comply could jeopardize a producer's payment eligibility.

FSA offers several disaster assistance programs for producers recovering from the impact of a tropical storm or hurricane. Key programs include:

The Tree Assistance Program (TAP), which provides financial
assistance to eligible orchardists and nursery tree growers to
replant or rehabilitate eligible trees, bushes, and vines lost by
natural disasters.

- The Emergency Forest Restoration Program (EFRP), which
  provides payments to eligible owners of nonindustrial private forest
  land in order to carry out emergency measures to restore land
  damaged by a natural disaster.
- The Emergency Conservation Program (ECP), which provides emergency funding and technical assistance to farmers and ranchers to rehabilitate farmland and conservation structures damaged by natural disasters and implement emergency water conservation measures in periods of severe drought.
- The Noninsured Crop Disaster Assistance Program (NAP),
  which provides financial assistance to producers of noninsurable
  crops when low yields, loss of inventory, or prevented planting
  occur due to natural disasters.
- The Emergency Assistance for Livestock, Honeybees, and Farm-raised Fish Program (ELAP), which provides financial assistance to eligible producers of livestock, honeybees, and farmraised fish for losses due to disease and certain adverse weather events or loss conditions.
- The Livestock Indemnity Program (LIP), which provides benefits
  to livestock producers for livestock deaths in excess of normal
  mortality caused by adverse weather or attacks by animals
  reintroduced into the wild by the federal government.
