INSTRUCTIONS FOR APPLICANTS FILING FUTURE LAND USE MAP AMENDMENT APPLICATIONS (SMALL-SCALE)

The following information is required from an applicant filing a small-scale future land use map amendment application:

- 1. Copy of property deed.
- 2. Copy of aerial map with property owners from Property Appraiser's Office with the subject property highlighted.
- Legal description of subject property, if the legal description in the deed is larger than the actual property being applied for.
- 4. 1, 600 application fee.
- 5. Completed application (attached).
- 6. Map, as described on attached application.
- 7. Authorization letter from owner, if owner is represented by an agent (see attached sample).

The above information must be submitted to the Planning & Zoning Office, 224 Pine Avenue, Live Oak, Florida 32060 by the 15th day of any month in order to be heard by the Planning and Zoning Board on the last Thursday of the following month (approximately 45 days later).

The Planning and Zoning Board hearing is the first public hearing. The Planning and Zoning Board will then make an advisory recommendation concerning the request to the Board of County Commissioners. The Board of County Commissioners will hold a public hearing approximately two weeks later. The Board of County Commissioners will consider the recommendation of the Planning and Zoning Board and will make the final decision on whether to grant or deny the application. Meeting dates are subject to change. The Planning & Zoning Office will notify the applicant by mail of the exact date, time and place of the hearings.

Public notices of hearings will be published in the legal section of a local newspaper. A sign giving public notice of hearings will also be posted on the subject property. The Planning & Zoning Office will ensure these requirements are met. In addition, the Planning & Zoning Office will send letters to all landowners who own property in close proximity to the subject property,

The burden is on the applicant to furnish competent evidence to prove that the request is consistent with the Comprehensive Plan and complies with all procedural requirements. Anyone may appear at the hearings to comment on the application.
